### Course

All tests are a single course without a bird field. Bobwhite quail will be used in all tests. Only blank pistols (starter pistol) may be used. All live shooting in master & senior tests will be done by official gunners. Handlers in the master test will be required to carry an unloaded shotgun or an “imitation” long-barreled gun. Handlers and gallery members in the master and senior braces will be required to wear blaze orange. NO horseback handling or gallery riders will be permitted. Tracking collars are NOT permitted.

Please bring chairs, stakeouts/kennels, and water bowls. The weather in Louisiana can be unpredictable and change greatly from morning to afternoon.

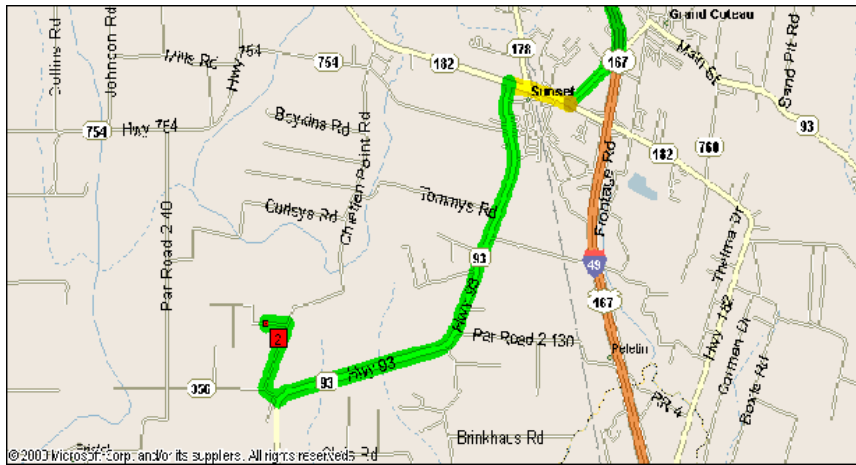
Please plan accordingly.

### Coming from I-49 North or South



### From I-49 Southbound:

- Exit #11 (Sunset/Grand Coteau), southwest (Main St) for 0.1 mile.
- Continue southwest on Hwy 93 (Duffy Avenue) 0.4 mile.
- Bear right (west) continuing on Hwy 93/Hwy 182 for 0.6 mile.
- Turn left (south) on Hwy 93 for 3.8 miles.
- Turn right onto Hwy 356 for about 1/4 mile, to Chretien Point Rd.
- Continue on Chretien Point Rd for about 1/2 mile and turn left on Henry Rd (one lane gravel road)
- Travel about 1/2 mile down Henry Rd to gate on right which is Neupoint Farm.

- Exit #97 off I-10 (Scott/Cankton), it is one exit west of Lafayette.
- Head north on Hwy 93 toward Cankton.
- Go about 9 miles north on Hwy 93

- Take a left onto Hwy 356
